In an evolving health and care landscape there is an increasing recognition of the need to shift from reactive to preventative approaches in regulation. This conference seeks to contribute to that shift by harnessing insights from research to inform policy and practice. The event is for researchers, policy professionals, regulators, register holders, educators, healthcare leaders and anyone interested in improving regulation and registration for patient safety, public protection and public confidence, and how that can be achieved through research.

This collaborative event aims to bridge academic research with regulatory and policy practice to co-produce actionable knowledge. The event will help shape future research agendas, foster collaborations, and inform strategies for embedding prevention across regulatory practice. It will be complementary to the PSA's current work on refocusing regulation which seeks to articulate what it means to shift the focus more towards preventative approaches, to create conditions in which care is safer and better, and harm less likely to occur.

Introduction and morning session

Alan Clamp

Alan has been the Chief Executive of the Professional Standards Authority for Health and Social Care (PSA) since 2018. The PSA promotes the health, safety and wellbeing of patients, service users and the public by raising standards of regulation and voluntary registration of people working in health and care.

Alan was previously the Chief Executive of the Security Industry Authority (SIA). The SIA is a public body established under the Private Security Act 2001 to regulate private security in the UK. Between 2011-2015 Alan held the post of Chief Executive at the Human Tissue Authority (HTA), an independent regulator sponsored by the Department of Health.

In addition to his role at the PSA, Alan is a Non-Executive Director at the Intellectual Property Regulation Board, a member of the Regulatory Board at the Association of Chartered Certified Accountants and a Trustee of the Institute of Regulation.

Roberta Fida

Roberta Fida is a Full Professor of Organisational Behaviour and Organisational Psychology at Aston Business School, where she serves as Head of the Leadership and Management Department. She is a Chartered Occupational Psychologist and Senior Fellow of the Higher Education Academy. Her research focuses on work stress and unethical behaviour at work, particularly the mechanisms of moral disengagement and self-efficacy in shaping conduct. She has published over 80 papers in leading journals such as Human Relations, Journal of Organizational Behavior, and Journal of Business Ethics.

Rosalind Searle

Rosalind H. Searle holds the chair in Human Resource Management and Organisational Psychology at the University of Glasgow's Adam Smith Business School, in Scotland, UK and founding director of the European Association of Work and Organizational Psychology's Impact Incubator (www.Eawopimpact.org). Rachael Culverhouse-Wilson

Rachael Culverhouse-Wilson is Head of Legal and an in-house barrister at the Professional Standards Authority ('PSA'), which oversees the 10 statutory bodies that regulate health and care professionals. Rachael is responsible for leading the section 29 function and team in relation to potential appeals of fitness to practise decisions made by these bodies and to conduct litigation on behalf of the PSA. Rachael has worked in health and social care regulation for over 10 years, working for two other health care regulators including as Head of Legal. Rachael holds a Masters of Law (LLM) degree in Public Law and Global Governance and is an Academic Masters in Law Advisory Board member for the University of Law.



Afternoon session

Anna van der Gaag

Anna van der Gaag is a Visiting Professor of Ethics and Regulation at the University of Surrey, with an interest in what makes and breaks good healthcare. Anna has held senior appointments in the health, social care and legal sectors over two decades and is currently Senior Independent Director of an NHS Mental Health Trust. Until recently she chaired the Advisory Board for Safer Gambling at the UK's gambling regulator, and the NMC's Midwifery Strategic Advisory Panel, where she was instrumental in bringing people with lived experience of gambling harm, and women who use maternity services, into regulatory decision making.

Anna is active in research in regulation internationally. In 2009, when Chair of the Health and Care Professions Council, she introduced the first regulatory research strategy by a UK health regulator, leading to a series of commissioned research projects on alternative dispute resolution, restorative justice, understanding the impact of fitness to practice and increasing the involvement of people with lived experience in regulation. Her more recent regulatory research has included testing the use of Al in nurse fitness to practice decision making in the US, Australia and the UK, but her main interest lies in developing more restorative and person centred approaches to handling complaints about health professionals. Her current research with the Australian health regulator is examining the impact of complaints handling on health practitioners working in rural and remote areas who are internationally qualified. She was awarded a CBE for services to health and care in 2015.

Gerry McGivern

Gerry McGivern is a Professor in Public Services Management & Organisation at King's Business School. His research focuses on understanding how professional knowledge, practices, identities, and leadership are affected by regulation, management, and organisation, primarily in healthcare systems in the UK and East Africa. His research aims to improve management, organisation, leadership, and regulation in public services. Gerry's research has impacted the Professional Standards Authority's and General Osteopathic Councils' health professional regulation policy in the UK and his research on how to improve health professional regulation in Kenya and Uganda was recently cited in World Health Organization (WHO) guidelines on health practitioner regulation

Marie-Jeanne Royer

Martin Elliott

She has been called upon to provide independent expert advice to a range of public and third sector bodies including advising the Scottish Government as an invited member of an Independent Expert Group on Unlocking the Value of Data, and the Infected Blood Inquiry on the statutory and professional duties of candour. Dr Sorbie is a Deputy Director of the Mason Institute for Medicine, Life Sciences and the Law, and an appointed member of the BMA's Medical Ethics Committee. She served on the Patient Safety Group of the Royal College of Surgeons of Edinburgh from 2018 – 2024.

Mary Tumelty

Ben Palafox
